1. In separate financial statement:

- The financial income was increased due to benefit from higher early repayments interest that received in the 2nd quarter 2025 compared to the same period in 2024.
- The decrease in selling expenses was due to slightly drop maintenance and repair costs of assets, as well as a decline in the other expenses.
